## **Price List 2022 of the Service Facility Bahnbetriebswerk Krefeld**

### **1. Preliminary Remarks**

The use of the tracks and depot facilities of the Bahnbetriebswerk Krefeld Betriebs-GmbH & Co. KG (BwK) is subject to charge. All prices mentioned hereinafter are net prices. Railway tracks are including, all the tracks used for train composition, for the provision of wagons and trains or for temporary parking of wagons and traction units (shunting tracks, Parking tracks and switches ).

The use of the other service facilities is stated separately (workshop space, train washing track etc.). This also applies to possible additional costs within the scope of use, such as electricity, water, fuel and sand for the sanding device.

In addition to the use of the depot facilities, the price of use is also covering the operations control during the official opening hours (Monday to Saturday, from 8.00 am to 8.00 pm). Shunting operations are invoiced according to the number of shunting operations. When using the depot facilities outside the official opening hours, an additional charge of 280.00 € per operation will be invoiced.

### **2. Pricing**

According to the price list below.

Only full days will be invoiced.

Parking of locomotives are invoiced on a parking space basis.

*Example:*

*Arrival on Tuesday 10.00 am – Departure on Thursday 2.00 pm*

*Three days will be invoiced.*

### 3. Ordering of Depot Services

Depot facilities or services can only be used after a prior order has been placed - in case of existing free capacities, the order can also be placed on very short notice.

The required order form can be downloaded from our website "www.bw-Krefeld.net".

### 4. Cancellation of Depot Facility Use

until the 30<sup>th</sup> day before the start of the use:

free of charge

after the 14<sup>th</sup> day and until the 29<sup>th</sup> day before the start of the use:

25 % of the agreed rental price, however, at least 150.00 €

after 48 hours and until the 14<sup>th</sup> day before the start of the use:

50 % of the agreed rental price, however, at least 200.00 €

In case of cancellations within 48 hours before the start of the use as well as in case of non-use, the full rental price has to be paid.

The cancellation costs are a lump-sum compensation. The contracting party of BwK is expressly authorised to prove that no damage has occurred at all or that the damage caused is considerably lower than the lump sum compensation.

### 5. Price Adjustment for Depot Facility Use

The depot facility price list is based on a long-term calculation of Bw Krefeld. In compliance with § 24 EIBV (Railway Infrastructure Use Regulation), Bw Krefeld reserves the right to adjust the prices for the depot facility use. With the publication of a new depot facility price list the previous price list ceases to apply.

This agreement is recognized as binding through the use of the facilities.
